### Summary

Respondents continue to express optimistic expectations concerning macroeconomic conditions and development prospects for their enterprises. At the same time, the exchange rate forecast included in the 2018 state budget by the government resulted in a steep rise in depreciation expectations.

In the next 12 months, respondents expect:


- moderate inflation consumer prices are expected to go up by 10.4%, up from 10.0% in Q3;
- **growth in the output of goods and services -** the balance of expectations increased to 21.2%, up from 17.5% in Q3;
- buoyant business activity the business outlook index (BOI) was 115.2%, down from 117.4% in Q3. Economic activity keeps picking up at a high pace, largely due to respondents continuing to forecast growth in total sales and investment in machinery, equipment and instruments:
- a significant depreciation of the hryvnia the average UAH/USD exchange rate was UAH 29.30 per USD 1 compared to UAH 28.46 per USD 1 in Q3.
- high borrowing needs. Respondents intend to continue to receive loans, mainly domestic currency loans.

High energy and raw material and supplies prices remain the main factors that hamper production growth.

For the first time since the survey began, respondents said they would lack capacities if demand soared unexpectedly.



### **Survey Details**



- This **survey was carried out** from 3 November through 5 December 2017.
- A total of 670 respondents from 22 oblasts¹ were polled.
- A representative sample was generated on the basis of all main economic sectors and enterprise sizes based on staff number ².




# Expectations of the output of Ukrainian goods and services in the next 12 months improved further (1)



■ Respondents continued to expect a rise in the output of Ukrainian goods and services in the next 12 months - the balance of expectations was 21.2% compared with 17.5% in Q3. Positive expectations have continued for 7 quarters in a row.



# Expectations of the output of Ukrainian goods and services in the next 12 months improved further (2)



#### Output growth was expected:

- <u>in terms of economic activities</u>, by respondents from all main economic activities, except from transportation and communication and construction enterprises;
- in terms of size, by respondents from large, medium and small enterprises;
- in terms of business activities, by respondents from all enterprises;
- *in terms of regions*, by respondents from 20 oblasts, most of all by those from Zakarpattia oblast.
- A decline in output was expected by respondents from Ternopil and Odesa oblasts.







### Inflation expectations were little changed on the previous quarter









- Consumer prices were expected to rise by 10.4% (10.0% in Q3 2017).
- The percentage of respondents who believed that consumer prices would not rise by more than 9.0%, or would even decrease, was 40.4% (40.1% in Q3).

# The main consumer price drivers, the hryvnia exchange rate and production costs, remained unchanged







- Following two previous surveys, the **hryvnia exchange rate** was again ranked as **the most important driver** (77.9%, up by 11.8 pp).
- Respondents decreased their expectations of the influence of production costs (65.1% of responses, down by 8.0 pp).
- Increases were also reported in the influence of household income (up by 4.9 pp) and social spending (up by 5.5 pp).
- Money supply movements were ranked as the least important consumer price driver.

■ The **percentage of respondents who** said the hryvnia would depreciate grew to 88.5%, up from 79.4% in Q3.

- Most respondents (59.6%) expected that the UAH/USD exchange rate would exceed UAH 29.00 per USD 1.
- The average UAH/USD exchange rate was projected to hit UAH 29.30 per USD 1 in 12 months (UAH 28.46 per USD 1 in Q3).

At the time of the survey, the weighted average exchange rate in the interbank foreign exchange market averaged UAH 26.76 per USD 1. Daily fluctuations did not exceed 2.8% of the average figure (UAH 25.63 per USD 1 in Q3 2017, with daily fluctuations being within a range of 1.8%).





# Respondents have been assessing their financial and economic standing as good for six quarters running







- Respondents assessed their current financial and economic standing as good the balance of expectations rose to 7.5%, up from 7.2% in Q3.
- Positive assessments were given:
  - <u>in terms of economic activities</u>, by respondents from manufacturing, agricultural, trade and construction enterprises, as well as by respondents from other economic activities;
  - in terms of size, by respondents from large and medium enterprises;
  - *in terms of business activities*, by enterprises that perform only import or export transactions, and by those that perform export and import transactions;
  - <u>in terms of regions</u>, by respondents from 17 regions, with the best assessments reported by respondents from Ternopil and Chernivtsi oblasts.
- The lowest assessments were given: <u>in terms of economic activities</u>, by respondents from energy and water supply enterprises; <u>in terms of regions</u>, by respondents from Zaporizhzhia, Dnipropetrovsk, Chernihiv and Kharkiv oblasts. (Table 2.1)



### Finished goods stocks remained at a level lower than the normal one






- Respondents continued to assess their finished goods stocks at a level lower than the normal one. The negative balance of assessments rose to (-10.3%) compared with (-9.5%) in Q3.
- Respondents from mining and agricultural enterprises decreased their assessments of finished goods stocks.

# Respondents said they did not have any unutilized production capacity



- For the first time ever since the survey began, respondents said they would require additional capacity to meet a sudden increase in demand. The balance of assessments was (-1.3%) compared with 4.3% in Q3 2017.
- Shortages of unutilized production capacity were reported:
  - <u>in terms of economic activities</u>, by respondents from other economic activities, and by those from agricultural and trade enterprises (balances of responses of (-22.8%), (-13.8%), and (-9.2%) respectively);
  - <u>in terms of regions</u>, by respondents from 12 oblasts, the largest shortages being reported by respondents from Ternopil (-40.0%), Khmelnytskyi (-27.8%), and Ivano-Frankivsk (-25.0%) oblasts. Respondents from Volyn and Zhytomyr oblasts were operating on the verge of their capacity.



### Respondents continued to expect that business activity would pick up






- The **business outlook index** (BOI) was 115.2% compared with 117.4% in Q3 2017. This positive trend has persisted since Q2 2016.
- All respondents, except those from construction enterprises, expected a pick-up in business activity.
- The **most optimistic forecasts were given** by respondents from manufacturing enterprises (with a BOI of 127.1%), trade enterprises (118.1%), and other economic activities (116.2%).

#### The business outlook index of Ukrainian enterprises and its components




- Respondents increased their assessments of total sales, with these assessments remaining the highest.

## Respondents from almost half the regions reported an increase in the BOI


#### Business outlook index for next 12 months in terms of regions,%




- Respondents from all polled oblasts (22 oblasts) said economic activity would pick up.
- The **highest expectations** were reported by respondents from Lviv (a BOI of 132.3%) and Zakarpattia (126.6%) oblasts. The **lowest** expectations were reported by respondents from Dnipropetrovsk and Chernihiv oblasts (with a BOI of 103.5% in each).

Expectations of financial and economic standing for next


- The balance of expectations was 12.9% compared with 17.8% in Q3.
- Most respondents expected their financial and economic standing to improve. Only those from construction and energy and water supply enterprises expected a deterioration.
- The **highest expectations** were reported by respondents from manufacturing enterprises (a 21.8% balance of responses), with the **lowest** expectations reported by those from construction enterprises (-18.5%)

#### Respondents said that both total and external sales would rise



- Respondents have been strongly expecting **total sale growth** for seven quarters running, the balance of expectations being 26.5% compared with 24.9% in Q3 2017.
- All respondents, except those from construction enterprises, expected a rise in total sales. The highest assessments were given by manufacturing, agricultural and trade enterprises, with balances of expectations of 41.1%, 34.1% and 33.1% respectively.



# Respondents continued to report positive expectations of future investment (2)








- All respondents, except those from construction enterprises, expected in the next 12 months growth in both investment in machinery, equipment and instruments and construction investment.
- The **highest expectations of growth in investment in machinery, equipment and instruments** were reported by respondents from manufacturing enterprises (with a 40.0% balance of expectations), while respondents from energy and water supply enterprises reported the highest expectations of **construction investment** growth (35.5%).



### Expectations of foreign investment for next 12 months in terms of economic activities




- Foreign investment will continue to rise: the balance of responses was 15.7% compared with 18.1% in Q3 2017.
- The percentage of respondents who intended to attract foreign investment in the next 12 months was 24.0%, up from 22.6% in Q3.
- All respondents, except those from the agricultural sector, expected an increase in foreign investment, with respondents from energy and water supply and mining enterprises expecting it most of all.



#### Staff numbers will rise






- Respondents continued to expect staff increases at their enterprises in the next 12 months. The balance of expectations was 4.6% compared with 5.0% in Q3 2017.
- **Staff rises were** expected by respondents from manufacturing, trade and other economic activities; *in terms of regions*, by respondents from 15 oblasts, most of all by respondents from Lviv oblast. Respondents from Ternopil oblast said the staff level would be **unchanged**.



### The main factors that impede output growth were unchanged





- Respondents referred to high energy and raw material and supplies prices as the main factors that impeded output growth.
- Respondents reported a sharp increase in the **shortage of qualified staff** (26.9%, up by 4.5 pp) and a lack of working capital (35.5%, up by 3.0 pp).

### **Expectations of producer price growth increased**





- Respondents expected an upturn in both selling and purchase prices, with balances of responses being 90.5% and 67.4% respectively, compared with 86.2% and 61.4% in Q3 2017.
- The **highest expectations** of purchase price growth were reported by respondents from energy and water supply and manufacturing enterprises (balances of responses of 100.0% and 94.7% respectively). Meanwhile, respondents from trade, manufacturing and construction enterprises had the highest expectations of selling price growth (82.0%, 78.9% and 77.8% respectively).



### Selling price drivers remained unchanged

#### Assessment of selling price drivers



- Respondents said that **energy prices** (65.7% of responses) and **raw material and supplies prices** (60.4%) would push up selling prices **most of all**.
- Respondents reported an increase in the influence of the hryvnia exchange rate and wage costs (by 7.1 pp and 3.8 pp respectively).
- As in previous quarters, loans rates were believed to be the **least important** selling price driver (10.7% of responses).




Expectations of production unit costs for next 12 months in terms of economic activities




- Respondents reported higher expectations of an increase in production unit costs. The balance of responses was 59.4% compared with 52.0% in Q3 2017.
- The highest expectations of an increase in production unit costs were reported:
  - <u>in terms of economic activities</u>, by respondents from energy and water supply and agricultural enterprises (balances of responses of 72.7% and 69.0% respectively);
  - <u>in terms of size</u>, by respondents from large enterprises (70.9%);
  - *in terms of business activities*, by respondents that perform export and import transactions (62.8%);
  - *in terms of regions*, by respondents from Rivne and Khmelnytskyi oblasts (86.7% and 78.9% respectively).
- The lowest expectations were reported:
  - *in terms of economic activities*, by respondents from trade enterprises (47.1%);
  - in terms of size, by respondents from small enterprises (49.1%);
  - in terms of business activities, by respondents that perform only import transactions (53.0%);
  - in terms of regions, by respondents from Volyn and Kirovohrad oblasts (33.3% and 41.2% respectively).



### Wage costs per staff member will rise faster





- More respondents said they expected a rise in wage costs per staff member. The balance of responses was 67.7% compared with 61.2% in Q3 2017.
- The highest expectations were reported:
  - <u>in terms of economic activities</u>, by respondents from manufacturing enterprises (with a balance of responses of 75.2%);
  - *in terms of size*, by respondents from large enterprises (75.1%);
  - in terms of business activities, by respondents that perform only export transactions (72.8%);
  - <u>in terms of regions</u>, by respondents from Chernivtsi and Volyn oblasts (90.0% and 86.7% respectively).
- **■** The lowest expectations were reported:
  - <u>in terms of economic activities</u>, by respondents from mining enterprises, with a balance of responses of 55.3%;

- *in terms of size*, by respondents from small enterprises (57.4%);
- *in terms of business activities*, by respondents that perform no export or import transactions (64.9%);
- in terms of regions, by respondents from Dnipropetrovsk oblast (52.3%). (Table 3.10)





### Respondents continued to report borrowing needs






- Respondents slightly reduced their expectations of an increase in borrowing needs in the near future: the balance of responses was 36.8% compared with 37.8% in Q3.
- The **highest borrowing needs** were reported:
  - *in terms of economic activities*, by respondents from mining enterprises, with a balance of responses of 68.8%;
  - *in terms of size*, by respondents from medium enterprises (38.7%);
  - <u>in terms of business activities</u>, by respondents that perform only export transactions (40.0%);
  - *in terms of regions*, by respondents from Volyn oblast (66.7%).
- The lowest needs were reported:
  - in terms of economic activities, by respondents from agricultural enterprises (28.0%);
  - *in terms of size*, by respondents from small enterprises (30.1%);
  - in terms of business activities, by respondents that perform no export or import transactions (33.1%);
  - <u>in terms of regions</u>, respondents from Chernihiv oblasts expect their borrowing needs to decrease (-22.2%).


- The percentage of respondents who intend to receive loans was 39.3%, up from 38.5% in Q3 2017.
- The respondents most likely to receive loans are:
  - in terms of economic activities, respondents from manufacturing enterprises (53.6% of responses);
  - *in terms of size*, respondents from large enterprises (48.2%);
  - <u>in terms of business activities</u>, respondents that perform export and import transactions (51.1%);
  - *in terms of regions*, respondents from Ternopil oblast (57.1%).



### Most respondents intended to receive national currency loans







- The percentage of respondents who intend to receive hryvnia loans was 86.4%, up from 81.5% in Q3 2017.
- The respondents most likely to receive national currency loans were:
  - *in terms of economic activities*, respondents from agricultural enterprises (97.3%);
  - *in terms of size*, respondents from small enterprises (93.9%);
  - *in terms of business activities*, respondents from enterprises that perform only export transactions (95.0%);
  - <u>in terms of regions</u>, respondents from Vinnytsia, Volyn, Zhytomyr, Rivne, Ternopil, Khmelnytskyi, Cherkasy, Chernivtsi and Chernihiv oblasts plan to receive **only hryvnia loans**.
- The respondents most likely to receive foreign currency loans are:
  - *in terms of economic activities*, respondents from mining enterprises (42.9% of responses);
  - in terms of size, respondents from large enterprises (23.9%);
  - in terms of business activities, respondents that perform export and import transactions (24.0%);
  - *in terms of regions*, respondents from Kherson (33.3%) and Zakarpattia oblasts (25.0%).

# The main factors that deter enterprises from receiving loans were unchanged







- Respondents said that high loan rates continued to be the main factor that deterred them from receiving new loans (68.2% of responses).
- The following factors were significant:
  - for respondents from energy and water supply enterprises collateral requirements and uncertainty about their ability to meet their debt obligations as they fall due (48.5% and 39.4% of responses respectively);
  - for respondents from construction enterprises collateral requirements (48.1% of responses).

# Respondents slightly increased their assessments of lending condition harshness





- For the first time since Q1 2016, **respondents said that lending conditions had tightened** (the balance of assessments rose to 23.9% compared with 21.5% in Q3).
- A decrease in assessments was reported by respondents from the agricultural and trade sectors.
- The highest assessments were reported by respondents from energy and water supply enterprises (a 28.6% balance of responses), while the lowest assessments were reported by respondents from mining enterprises (9.1%).

■ The percentage of respondents that said they had not had any difficulties with effecting banking transactions was 95.2%, up from 94.1% in Q3.
