2. Methodology	
<u>2.1 Concepts and definitions</u>	<p>2.1.1 Concepts and definitions</p> <p>The PFTS Index is the official index of PFTS Stock Exchange and is based on the results of trades in the PFTS Stock Exchange. It is calculated in real time during trading session.</p> <p>The PFTS Index is a price index weighted by the volume of issue (free float) available for a wide range of investors.</p> <p>The PFTS Index is the official index of PFTS Stock Exchange and is out of the mandate of the state statistics services.</p> <p>The concept and definitions of data falling under <i>Stock market: PFTS Index</i> category comply with recommendations set forth in items 5.23-5.25 in <i>The Special Data Dissemination Standard: Guide for Subscribers and Users (SDDS Guide)</i> (IMF, 2013).</p>
<u>2.2 Scope</u>	<p>2.2.1 Scope</p> <p><i>Scope of the data</i></p> <p>The PFTS Stock Exchange trades with securities of the Ukrainian issuers. The information about the issuers is registered in compliance with the requirements of the Ukrainian legislation.</p>
<u>2.3 Classification/sectorization</u>	<p>2.3.1 Classification/sectorization</p> <p>The PFTS Index Watch List is prepared based on the recommendations of the PFTS Index Committee for the securities from the PFTS List based on capitalization, trading volume, quantity of agreements, size of free float and other factors influencing the liquidity of shares.</p>
<u>2.4 Basis for recording</u>	<p>2.4.1 Valuation</p>

	<p>The PFTS Index is calculated based on the principle of market weighting. The calculation of the PFTS Index covers all agreements registered on the PFTS Stock Exchange during the trading session, if they meet certain conditions. The list of shares, the PFTS Index is comprised of, undergoes review (changes) two times per year - on the 15 of April and on the 15 of October. If the enterprise covered by the PFTS Index is for some reason removed from the PFTS List, the withdrawal from the list of enterprises in the index basket comes automatically.</p> <p>2.4.2 Recording basis</p> <p>The PFTS Index is the official index of PFTS Stock Exchange and is out of the mandate of the state statistics services.</p> <p>All the PFTS members are within one framework of the Ukrainian laws on stock market and the PFTS internal rules and procedures. It means that the PFTS members do not only comply with the state regulations but also have agreed to take additional obligations that would guarantee a level playing field in the market.</p> <p>The confidentiality of information is protected by the <i>Law of Ukraine On Information №2657-XII of 02.10.1992 (as amended)</i>.</p>

<u>3.1 Source data</u>	<p>3.1.1 Source data collection programs</p> <p>PFTS Index is calculated based on official results or on results of the current PFTS auction.</p> <p>3.1.2 Source data definitions, scope, classifications, valuation, and time of recording</p> <p>Source data are in full conformity with source data definitions, scope, classifications, valuation at the time of recording, as stated in items 2.1.1 – 2.4.3.</p> <p>3.1.3 Source data timeliness</p> <p>The source data are submitted on time within the trading hours.</p>
<u>3.2 Assessment of source data</u>	<p>3.2.1 Source data assessment</p> <p>The source data system is automated and ensures proper data control at each stage.</p>
<u>3.3 Statistical techniques</u>	<p>3.3.1 Source data statistical techniques</p> <p>The PFTS Index is automatically calculated by the Index-server based on the data of trading system. The index-server contains the PFTS Index controls and accuracy checks.</p>

<u>4.3 Revision</u>	<p>4.3.1 Revision schedule</p> <p>Data revision schedule is not applicable.</p> <p>4.3.2 Identification of preliminary and/or revised data</p> <p>The data are final when first published and are not subject to any revision.</p> <p>4.3.3 Dissemination of revision studies and analyses</p> <p>The data are final when first published and are not subject to any revision. Information about changes in the methodology for compiling the PFTS Index is made public by the PFTS Stock Exchange.</p>
